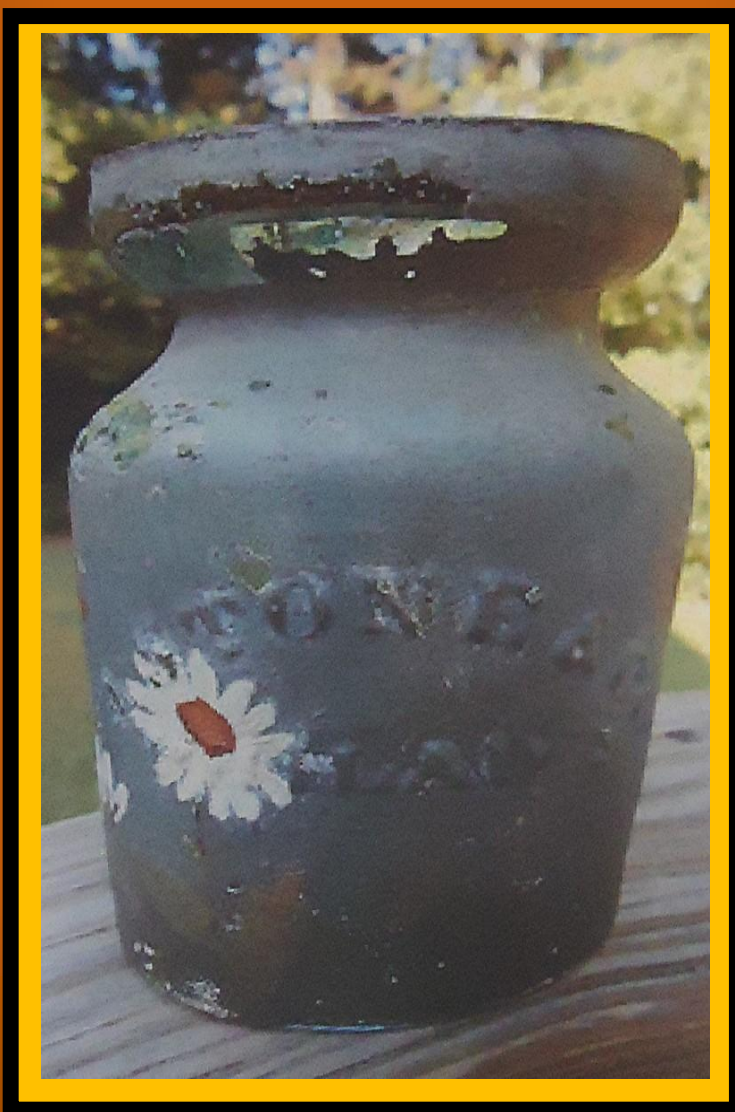

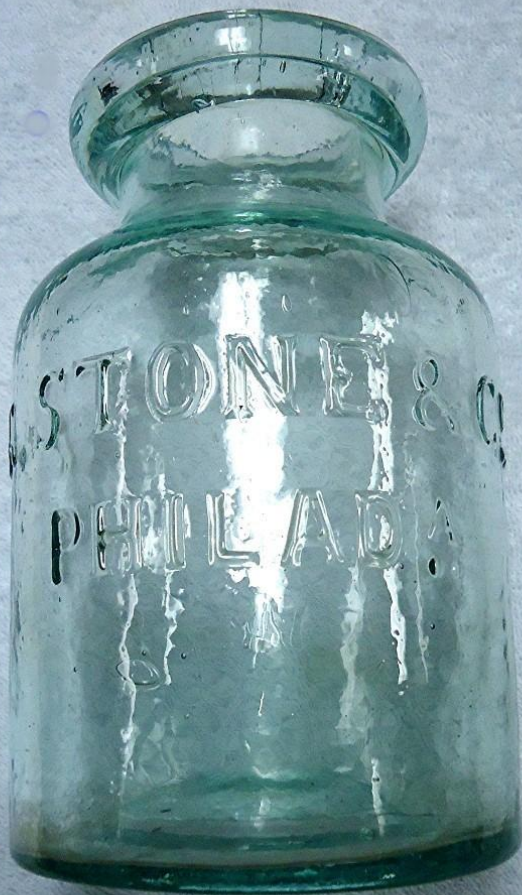

The impending Pure Food and Drug Act of June 30, 1906 will also lead to the decline of many cures and concoctions.

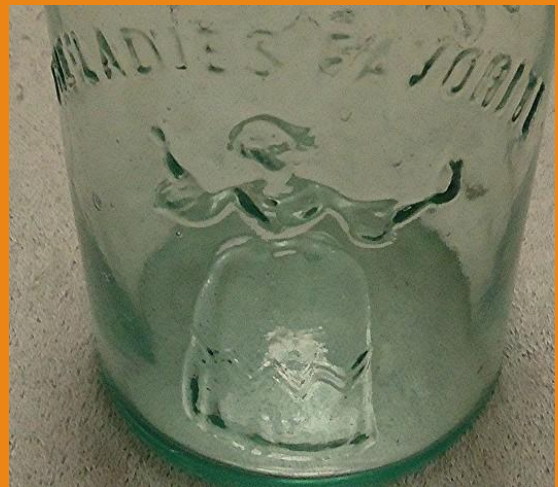

Show and Tell



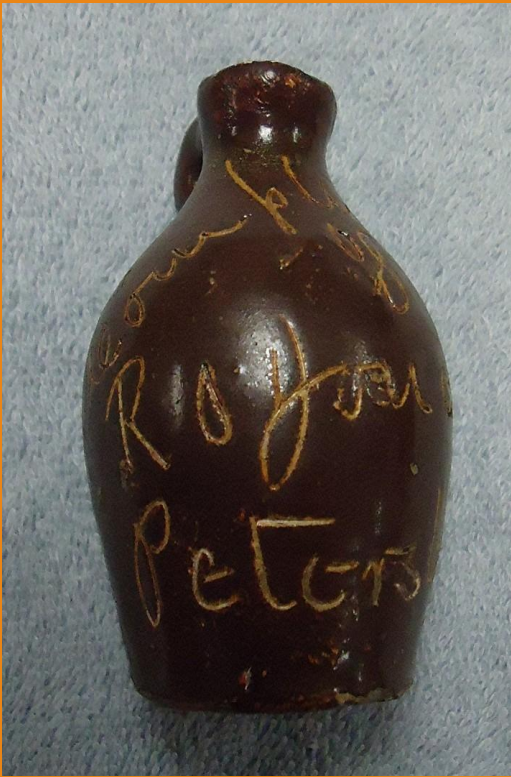
This nice THE LADIE'S FAVORITE is another super nice canning jar from Joe William's collection. This is one of the rarest jars around. This jar, with the original lid, sells for 8 to 10 thousand dollars. Without the lid the value is about half that. This jar is just one example of the types of items you will see at the Raleigh Bottle Club meetings on the first Tuesday of each month. 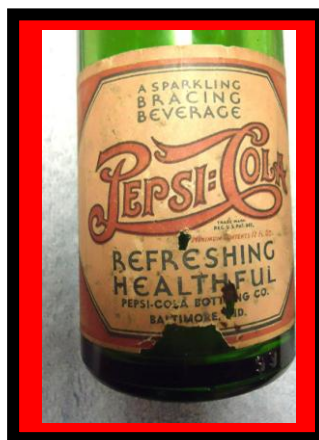
This nice JOHN Y. MAC RAE pharmacy bottle from Raleigh, NC was presented by Whitt Stallings.



RBC member Tom Walsh presented this nice early paperweight from the early 1900's. Because of the sandy soil and warm temperature the southern coast of North Carolina, South Carolina and Georgia was ideal for growing Pine forests. The rosin from the pine trees was used to make tar, pitch and turpentine. These were valuable natural sources used in the early ship building industry. S.P. Shotter was a pioneer in the Tar, Pitch and Turpentine business. Paperweights like this were used to advertise his product.



This nice R.O. Jones mini jug from Petersburg, Va. was shown by Pem Woodlief. This is quite an unusual item. Jugs without the initials sell in the 50 to 75 dollar range. This one is a little more difficult to find which might very well double the value.



Warren Casper brought these nice paper label Pepsi bottles to show and tell. Take a little time to look at the differences in the three bottles. All are from the same time frame but the labels vary considerably. Nice paper label bottles produced prior to 1950 are getting very scarce. Check out the unusual cap on the green bottle. Thanks to Warren for bringing these to 'show and tell'.



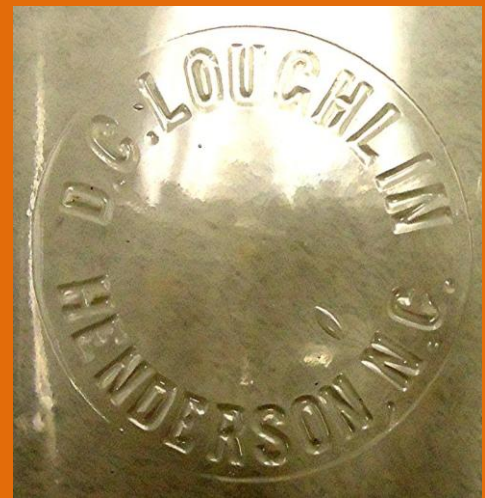

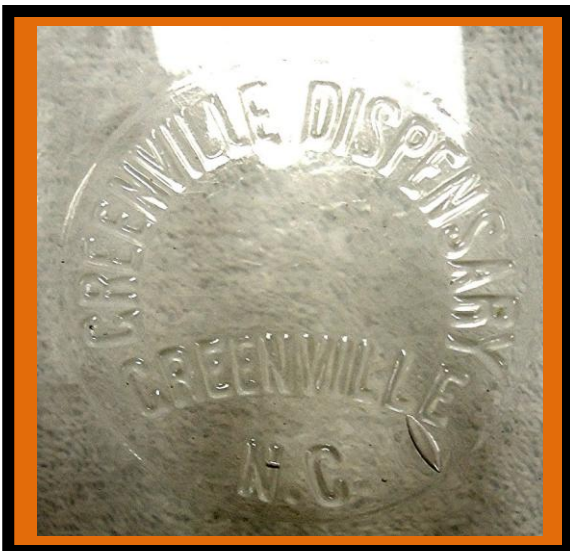

A True Pepsi Treat

Our guest speaker for October was Jeff Fitzgerald. Jeff is the Burnett family historian and is married to the daughter of the last Burnett in the Pepsi business. Jeff works for his father-in-law at the Pepsi plant in Roxboro, N.C. He is currently working on a book detailing the Burnett family and their involvement with Pepsi.

Thanks to Jeff for sharing his time and vast knowledge of early Pepsi history with the RBC.

FROM THE PEPSI ARCHIVES

Marvin Burnett, Henry Fowler (Charlotte) and John Jessup (Charlottesville) were called to Washington, D.C. around 1927 to answer a lawsuit filed in the Trademark Office by Coca-Cola. Coca-Cola claimed the Pepsi trademark should be voided due to alleged abandonment claiming they had been off the market for several years prior. These three bottlers testified they had indeed continued to bottle Pepsi since they had stockpiled concentrate just before its 1923 bankruptcy filing. Coke's case was thrown out and Pepsi's new owner, Roy Megargel, was most grateful. In spite of Megargel's effort he could not get Pepsi off the ground. He eventually sold the business to Loft Candy Company. However, he did not forget his friends. As part of a purchase agreement, Marvin Burnett was not required to reapply for his franchise. As part of the sale Megargel was contracted to receive from Loft a royalty of one penny/gallon on all fountain syrup sales plus an annual payment of \$10,000 for ten years. He received his first annual payment, but never received another penny.

Another Glass Bottle Bites The Dust

End of the line for returnable Coca-Cola bottle

NEW YORK — It's the end of an era for Coca-Cola lovers, as the last 6.5-ounce returnable, glass bottle rolls off the production line.

A small Coke bottler in Minnesota says it's stopping production of the bottles, which customers could return to get back a 20-cent deposit. The company in Winona, Minn., had been refilling the return-

able bottles since 1932 but said it no longer makes business sense to continue doing so.

LeRoy Telstad, the bottler's vice president and general manager, says the last run for refilling the bottles was Tuesday.

The Coca-Cola Co., based in Atlanta, notes that its 8-ounce glass bottles are still widely available across the country. Those recyclable bottles are nearly

identical to the smaller 6.5-ounce bottles. They have less glass but hold more cola.

The glass bottles that were refilled in Winona, Minn. had a very limited footprint, distributed in only four counties.

"They were made on an old line that would have to be completely replaced — they kept them going as long as they could," said Susan Stribling, a Coca-Cola spokeswoman.

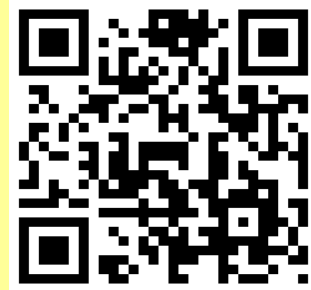

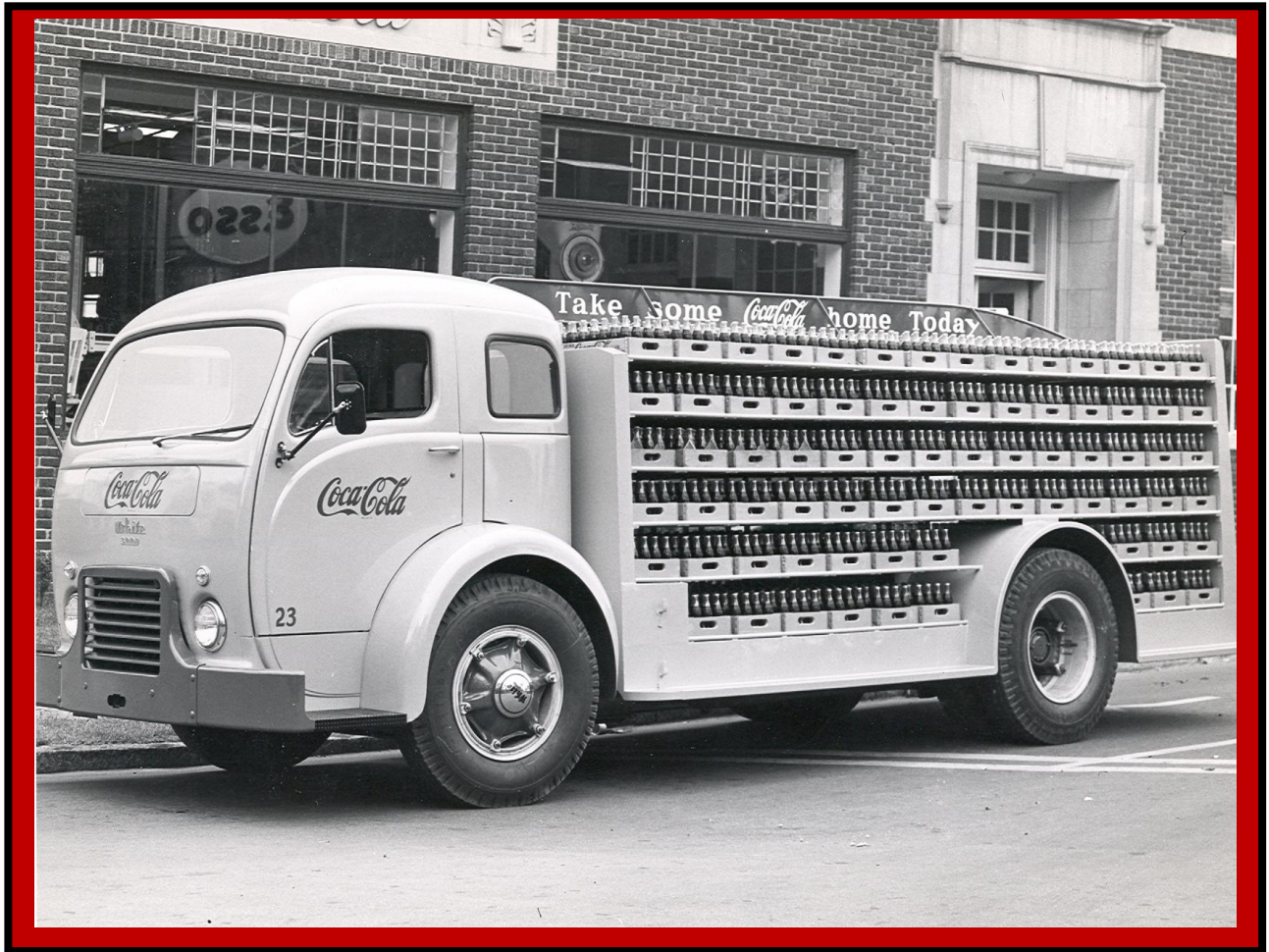
